1 Billing instructions

The communications between networks within the same region are free of charge and do not require a bandwidth package to be purchased. To connect networks between different regions, you must buy a bandwidth package.

Billing method of bandwidth packages

Each bandwidth package is billed based on the bandwidth, and the bandwidth costs of different interconnection areas are different.

- Billing item: Bandwidth, the minimum bandwidth is 2 Mbps
- Billing method: Subscription
- Billing cycle: per month

Bandwidth package type

When purchasing a bandwidth package, you must specify the interconnected areas. Each area contains one or more regions. According to the interconnected areas, the bandwidth package is divided into the following three types, and the cost of each type is different.

**Note:**

Bandwidth packages are required only when the cross-region communication is needed. No bandwidth package is required for the communication in the same region.

2 Overdue instructions

The Cloud Enterprise Network service will not be suspended immediately when a bill is overdue. Renew your service on time to reduce the impact on your business.

Stop instances

The instance is locked and the service is stopped when a bill is overdue but does not exceed 15 days. In this case, you cannot perform any operation on the instance, and the instance no longer forwards any traffic. However, the related configurations of the instance are reserved. If you recharge your overdue payment within 15 days of the service being stopped, the instance is automatically restarted.

Release instances

If you do not recharge your overdue bill 15 days after the service is stopped, the instance is released. The instance configurations are also deleted, and cannot be restored.

3 Buy a bandwidth package


To connect networks in different regions, you must buy a bandwidth package and set the region connection. Region connection refers to the cross-region bandwidth. Connecting networks in the same region does not require a bandwidth package.

Prerequisites

Procedure

1. Log on to the [CEN console](#).
2. Click the ID of the target CEN instance.
3. On the **CEN** page, click **Bandwidth Packages** and then click **Buy Bandwidth Package (Subscription)** or **Buy Bandwidth Package (Pay-As-You-Go)**.
4. Configure the bandwidth package according to the following information:

| Configuration | Description |
|---------------------------------|--|
| Cloud Enterprise Network | Select the CEN instance that requires a bandwidth package. |
| Areas | Select the areas to connect. |
| Bandwidth | Select the bandwidth of the bandwidth package. <div> Note: The interconnection area cannot be modified after the bandwidth package is created.</div> |
| Bandwidth Package Name | Enter the name of the bandwidth package. |
