1 Billing method

Alibaba Cloud provides a wide range of SSL digital certificate services.

Certificate pricing is CA-specific. Factors that affect certificate pricing include root certificate brand, certificate type, number of domains, number of wildcard domains, and the service duration.



2 Purchase guide

After SSL certificate is paid, you are required to submit an application and pass review before you can apply the certificate to cloud product. You may visit SSL certificate console to purchase and apply for SSL certificate.


To purchase digital certificates with Alibaba Cloud Certificates Service, follow these steps:



Procedure

1. Log on to Alibaba Cloud Certificates Service purchase page.

2. Select the Region, Category, Brand, Type of Domain, and the number of Domains to be added.



For certificate brands and categories, please refer to SSL certificate configuration table

- 3. Select the Quantity of the certificates.
- 4. Select the Duration, that is, the validity of the certificate.
- 5. Click Buy Now and complete the payment.
- 6. In the Alibaba Cloud Certificates Service console, complete the certificate order information.
 - · Enter the information of the domains to add.

The number and type of domains must be the same as those on the purchased certificate order.

- · Enter your application information.
- · Upload the certificate request file (CSR file).
- 7. Download the review file template.
- 8. Prepare the required review materials. and please refer to Apply for and validate certificates
- 9. Upload electronic copies of the review materials and submit the application.

3 New purchase upon expiration

The validity period of an Alibaba Cloud SSL certificate is one or two years, depending on the type of the certificate. Once your SSL certificate expires, you need to purchase a new one.

Payment

Post-payment is not accepted. You must pay first to activate the service.

To request a fee-based certificate, you must select the certificate type, the number of domain names, and the certificate brand. Then, you must pay for the certificate, enter the details for the certificate, and submit it for review. If your account balance is insufficient to cover the cost of the certificate, the follow-up operations will fail, and you will be unable to use Alibaba Cloud SSL Certificates Service.

New purchase upon expiration

SSL certificates cannot be renewed, and can only be purchased. Before your certificate expires, you need to log on to the Alibaba Cloud SSL Certificates console to purchase and apply for a new certificate.



Note:

Purchase the replacement certificate three to ten working days before certificate expiration so that the new certificate can be reviewed before the existing certificate expires.



Note

You need to re-bind the domain name for the new certificate.

Procedure

- 1. Log on to the Alibaba Cloud SSL Certificates console.
- 2. Click Purchase Certificate in the upper-right corner to go to the certificate purchase page.

3. Select the parameter values and complete payment.



Note:

If the brand and domain type of the new certificate are exactly the same as the previous certificate, the system automatically synchronizes the application information and review materials that were submitted previously. This will not shorten the duration of the review process.

- 4. Apply for an SSL certificate and re-bind the domain name.
- 5. Submit the material for review.
- 6. Install the newly purchased certificate on your server to replace the certificate that is about to expire.



Note:

If you do not install the new certificate on your server, the HTTPS will become unavailable once the previous certificate expires.

4 Refund instructions


You can request a full refund of a purchased SSL certificate any time before it is submitted for verification or after it fails the verification. You can apply for a refund in the Alibaba Cloud SSL Certificates console.

Prerequisites

You can apply for a full refund in the following situations:

- · Your purchased certificate has not been submitted for verification.
- · Your purchased certificate fails the verification.
- · After your purchased certificate is issued, you have up to 30 days to revoke the certificate and then apply for a refund.

You can view the issue date of the certificate on the certificate details page.





Note:

After 30 days from the issue date, you can no longer apply for a refund for your issued certificate.
