# 1 Billing method

Cloud Firewall has three editions: Advanced, Enterprise, and Flagship.

Currently, only the users with ECS instances based in Malaysia or Singapore can purchase the Cloud Firewall.

Cloud Firewall protects Alibaba Cloud assets including ECS, EIP, and intranet SLB. It currently does not support non-Alibaba Cloud servers.

**Billing example**

Assume that an Enterprise Edition user has 60 Alibaba Cloud assets with the bandwidth being 60 Mbit/s. Compared to the default number of supported Alibaba Cloud assets and default bandwidth, the user uses 10 additional ECS instances and 10 Mbit/s increased bandwidth. If this user subscribes to the Cloud Firewall service for six months, the service fee (unit: USD) is calculated as follows:  $(1,500 \text{ USD} + 4 \text{ USD} \times 10 + 16 \text{ USD} \times 10) \times 6$ .

## 2 Subscription

---

The Cloud Firewall service supports annual and monthly subscriptions. The minimum subscription period is six months.

### Procedure

1. Log on to the [Purchase Cloud Firewall](#) page.
2. Select the Cloud Firewall edition you want.



**Note:**

Cloud Firewall has three editions: Pro, Enterprise, and Flagmanship editions. Different editions support different features and billing methods. For more details, see [#unique\\_4](#) and [#unique\\_10](#).

3. Drag the slider to select the bandwidth or enter a bandwidth value in the Bandwidth text box.
4. Select a value for Subscription period.



**Note:**

The minimum subscription period is six months, regardless of the edition you select. A 15% discount is offered for subscriptions that last one year. The maximum subscription period is three years.

5. Confirm the order, select I agree to the terms and conditions of Cloud Firewall, and pay the subscription fee.

After the payment is complete, you can use the Cloud Firewall service in the Cloud Firewall console.



**Note:**

If you have subscribed to an edition and want to downgrade it to a lower edition, submit a work order to unsubscribe from the current edition and then subscribe to the lower edition.

## 3 Renewal and upgrade

---

To ensure that the security protection services run properly, renew your subscription to the Cloud Firewall service before it expires.

### Renew the subscription to the Cloud Firewall service

Within the five days after the Cloud Firewall service subscription expires, Alibaba Cloud retains your configurations and data in Cloud Firewall. If you renew the subscription within this period, you can continue to use the current configurations and data.

If you do not renew the subscription within this period, all your configurations and data in Cloud Firewall are released. If you want to continue using the Cloud Firewall service, you need to subscribe to it again. For more information, see [Subscription](#).

### Procedure

1. Log on to the [Cloud Firewall console](#).
2. In the upper-right corner, click Renew.
3. Select a value for Renewal period.
4. Select I agree to the terms and conditions of Cloud Firewall and pay the renewal fee.

After the renewal is complete, you can see the new expiration date in the upper-right corner of the Cloud Firewall console.

### Upgrade the Cloud Firewall service

1. Log on to the [Cloud Firewall console](#).
2. In the upper-right corner, click Upgrade.
3. Select the expected configuration and click Checkout.

After the payment is complete, the new version of the Cloud Firewall service takes effect immediately. You can see the new version information in the upper-right corner of the Cloud Firewall console.

## 4 Trial

---

This section describes how to activate the trial edition of Cloud Firewall, through which you can learn about the features of Cloud Firewall and how to use it.

### Limit

Cloud Firewall can be used for free for 7 days. After the trial is over, you must purchase the Cloud Firewall to use the cloud firewall function.




Note:

### Procedure


1. Log on to the [Cloud Firewall console](#).
2. Click Free Trial.



3. Click Authorize Other Accounts.

4. On the Cloud Resource Access Authorization page, click **Confirm Authorization Policy**.

After the authorization is complete, your cloud resources are accessible to Cloud Firewall and you can use the relevant services of Cloud Firewall.
