1 Pricing overview

You can learn the creation, billing, price range, and price affecting factors of DDH.

Purchase channels

You can purchase a DDH in the ECS console or via DDH API #unique_4.

Chargeable resources

You pay for DDH resources, such as CPU, memory, and local disks, on the basis of period of use. The number of ECS instances created on a DDH does not affect billing.

When you create an ECS instance on a DDH, you only pay for the image, cloud disks, and network bandwidth. You do not pay for the local storage and computing resources, such as CPU and memory. For more information about the billing of ECS related resources, see billing of ECS resources on a DDH.

Billing methods

#unique_6: Pay for a DDH before you use it. The DDH can be charged on a monthly or yearly basis.

Price affecting factors

The price of a DDH is influenced by the following factors:

- #unique_7: The specifications of a DDH.
- · Region: The physical location of the data center where a DDH is located.

2 Subscription

In this topic, you can learn about the payment methods supported by a Subscription Dedicated Host (DDH), the status of resources in different cases when a DDH expires, the renewal methods, viewing the bill, and the limits when using a Subscription DDH.

Subscription means paying for a DDH in advance for a specified term. According to the varied Billing Cycle, Subscription includes:

- · Pay-By-Year: The billing cycle is year.
- · Pay-By-Month: The billing cycle is month.

You can create Subscription or Pay-As-You-Go ECS instances on a Subscription DDH. For more information about the billing methods of ECS instances, see pricing overview of *Elastic Compute Service (ECS)*.

Payment Methods

You can pay for a Subscription DDH by using the following methods:

- · Credit cards or PayPal account linked to your account. For more information about how to link a credit card or PayPal account to your Alibaba Cloud account, see add a payment method in Account Management.
- · Coupons under your account that can be used to pay for Subscription products.



Note:

Log on to the Billing Management and go to Coupon Management page to view the Applicable Scenarios of your coupons and determine whether the coupons are applicable to Subscription products.

Billing period

Subscription DDHs are billed on a monthly, yearly or weekly basis. A billing cycle starts right from the second when DDH is purchased and ends at 00:00:00 (UTC+8) once the specified term of your purchase is fully used up. The billing cycle is based on the time of the UTC + 8 time zone.

For example: Hypothetically, you purchase a Subscription DDH at 13:23:56 on March 12, 2018, and pay for one-month use. The billing cycle ends at 00:00:00 on April 13, 2018.

DDH expires

When an account is not overdue and an DDH is not renewed successfully within 15 days after expiration, the resources on the DDH cannot be used normally. when a DDH expires after a billing cycle, the status of the DDH and its ECS resources are shown as follows.

Status changes after expiration

After a Subscription DDH expires, the status of its resources varies according to whether auto renewal is enabled.

Auto-renewal is disabled

If the auto-renewal is disabled, the status of the Subscription DDH and its ECS resources change as follows.

Expiration Date	Shuts down automatically within the following 24 hours.	Once the DDH shuts down, its ECS instances stop automatically and the system disks and data disks become unavailable, but data on them is retained.
15 days after expiration	Released automatically.	Automatically released, all data is lost and cannot be recovered.

Auto-renewal is enabled

If you have enabled auto-renewal, but a Subscription DDH is not renewed successfully after it expires, the status of the DDH and its ECS resources change as follows.

15 days after expiration	Shuts down automatically within the following 24 hours.	Once the DDH shuts down, its ECS instances stop automatically and the system disks and data disks become unavailable, but data on them is retained.

Renewal

After a billing cycle, you can perform manual renewal.

Alternatively, you can enable auto renewal for a Subscription DDH. When this feature is enabled, Alibaba Cloud charges the subscription fee to your linked credit card or PayPal account on the expiration date (T). If the payment fails, Alibaba Cloud tries again on Day 7 (T+6) and Day 15 (T+14) until the payment is successful. If all the three payment attempts fail, the DDH shuts down.

Conversion of billing methods

Currently, conversion of billing methods of a DDH is not supported. However, you can convert the billing method of an ECS instance from Pay-As-You-Go to Subscription on a Subscription DDH. For more information, see switch from Pay-As-You-Go to Subscription billing.

Limits

Using a Subscription DDH has the following limits:

- When you create a Subscription ECS instance on a Subscription DDH, the expiration time of the ECS instance cannot be later than that of the DDH.
- · When converting a Pay-As-You-Go ECS instance to a Subscription ECS instance, the expiration time of the instance cannot be later than that of the DDH.
- · A Subscription DDH is non-refundable.

3 Billing of ECS resources on a DDH

You can learn the billing rules of the ECS resources when running ECS instances on a DDH.

For the ECS instances hosted on a DDH, you are not billed for using vCPU, memory , and local disks. However, you must pay for chargeable images, cloud disks, and network bandwidth.

For more information about the billing rules of these ECS related resources, see #unique_15, billing of network bandwidth, and Pay-As-You-Go billing.

When the Pre-paid DDH does not expire or, there are different resource billing scenarios associated with the ECS instance that are running in different States.

Running ECS instances

When an ECS instance hosted on a DDH is in the Running status, all the ECS related resources are charged.

Stopped ECS instances

When an ECS instance hosted on a DDH is in the Stopped status, billing of the ECS related resources varies according to the billing method of the instance.

· Subscription ECS instances

After a Subscription ECS instance is stopped, the billing continues for all the ECS related resources.

· Pay-As-You-Go ECS instances

The no fees for stopped VPC instances feature does not apply to the ECS instances hosted on a DDH. When an instance is stopped, all its ECS related resources are billed as follows:

- Image: Retained. Billing continues for a chargeable image.
- Network bandwidth:
 - If the instance is assigned with a public IP address, the IP address will be released, and you do not get billed for network bandwidth.
 - If an EIP address is bound to the instance, the EIP address is retained, and billing continues for holding the EIP address and the network bandwidth.



Note:

When an ECS instance is stopped, its private IP address is retained.

- Cloud disks: Retained. Billing continues for the cloud disks.
