2 Rules for registering a domain name

You must follow the rules for registering a domain name.

For a Chinese domain name

The following rules apply when registering a Chinese domain name:

- The domain name must contain at least one Chinese character and may contain English letters , digits, and hyphens (-). It cannot consist of only English letters or digits.
- The domain name can be registered in simplified Chinese or traditional Chinese. If a domain name is registered in simplified Chinese, the equivalent domain name in traditional Chinese can no longer be registered. The converse operation also applies. This is designed to protect brands' domain names.
- Illegal characters can not be found at the end of the first row, such as: two-character (-), plus sign (+), (@), (&), spaces, etc;
- A Chinese domain name cannot contain only digits or only letters.

For an English domain name

The following rules apply when registering an English domain name:

- Only English letters (a-z; case-insensitive), digits (0-9), and hyphens (-) are supported. Spaces and special characters (such as !, \$, &, and ?) are not supported.
- The domain name cannot start or end with a hyphen (-), or use a hyphen (-) as the third or fourth character.
- The domain name can be up to 63 characters in length.

3 Buy a domain name

The following steps detail how to buy a domain name:

- 1. Log on to Alibaba Cloud domain. If you have no Alibaba Cloud account, apply for one.
- 2. Enter the domain name you want in the search box and click Find A Domain.
- 3. Select the domain name you want from the search results, and click Add to cart.
- 4. On the Shopping cart page, click Buy Now.
- 5. On the Confirm Order page, click Place Order.
- 6. On the Pay page, click Pay.

If the domain name you want is already registered, alternatives that have not already been registered may be available. For example, if the .com domain for www.justanexample.com is already registered, you can select another available domain such as .info and create www. justanexample.info instead.

Registering a premium domain name is the same procedure as registering an ordinary domain name, which means you can follow these steps as required.

Items of domain registration information

When registering a domain name, you must provide the relevant registrant, administrative, technical, billing, and DNS server information. These items are explained as follows.

- Registrant: the owner of the domain name. It must be genuine and valid.
- Admin Contact: in general, the registrant designates a technician in the company as the administrative contact. It has the permission to modify most of the domain name information, including the domain name registrant's address, zip code, phone and fax numbers, administra tive contact, technical contact, billing contact, and DNS server.
- Tech Contact: it has essentially the same permissions with the administrative contact. The ISP who provides the network server is the technical contact.
- PBilling Contact: it is mainly responsible for the billing of the domain name.
- DNS servers: they provide domain name resolution services for the registered domain names. At least two DNS servers are required to make sure that the DNS services are not interrupted. A DNS server must be a real and valid server in the Internet.

Modify domain registration information

According to the *Provisions* of the Internet Corporation for Assigned Names and Numbers (ICANN) and the "Domain Name Registration Agreement", Alibaba Cloud, as a domain name registrar, is duty bound to send you an email to verify any change in your domain registration information.

You must modify your domain name information as necessary.

Note:

- Once you receive such emails, you must check the domain name information in time and make sure that the information is correct.
- Otherwise, you may miss important notifications about the domain name and leave your domain name facing security issues.

According to the provisions of the "Domain Name Registration Agreement", the provision of false or invalid registration information or failure to update the registration information may cause the domain name to be disabled.
