1 Billing of physical connections

The billing method of the physical connection interface is Subscription.

Billing items

The physical connection service involves Alibaba Cloud fees and third-party fees.

- Alibaba Cloud fees

The physical connection interface fee is charged by Alibaba Cloud, including the initial installation fee and outbound traffic fee.

- If you access Alibaba Cloud using a dedicated port, you will be charged a one-time physical line interface initial installation fee and monthly resource usage fees.
- If you access Alibaba Cloud through the NNI partner with a shared port, you only need to pay the monthly outbound traffic fee, no need to pay the initial installation fee and resource occupation fee.

- Third-party fees

The fees charged by third parties (telecom operators, partners, and data center operators) include the leased-line fee and indoor cable rental fee. For more information, consult the third party.

Peering connection fee

In the process of peering connection, Alibaba Cloud charges for the initiator instance but does not charge for the acceptor instance. The fee depends on the bandwidth of the initiator instance and the distance between the two instances. The fee of VPC interconnection in the same region is lower than that of VPC interconnection between different regions.

- Cross-region interconnections are charged according to the prices shown on the purchase page. If you have any problem, contact your customer manager.

**Note:**

Before December 31, 2020, VPC interconnection between North China 2 (Beijing) and North China 3 (Zhangjiakou) is free.

- Same-region interconnections are charged according to the price listed in the following table.
This fee will not be charged until December 31, 2020.
