# 1 Billing of physical connections

The billing of physical connections involves fees charged by Alibaba Cloud and third parties.

### Billing method

Billing method	Description	Upgrade or downgrade	Overdue payment process
Subscription	Monthly or yearly subscription with the billing unit of USD/ month	Not supported	You will be notified about payment for a physical connection 15 days, 7 days, 3 days, and 1 day before the payment is due. 			devices, resources, and configurations associated with the physical connection are reserved (that is, the resources are not released).

### Billing items

The physical connection service involves Alibaba Cloud fees and third-party fees.

#### · Alibaba Cloud fees

The fee for a physical connection is charged by Alibaba Cloud and includes an initial installation fee, resource occupation fee, and outbound traffic fee.

- If you access Alibaba Cloud through a dedicated port, you need to pay a onetime initial installation fee for the physical connection. The resource occupation fee is charged on a monthly basis.
- If you access Alibaba Cloud through an NNI partner with a shared port, you only need to pay for the outbound traffic fee, which is charged on a monthly basis.

#### · Third-party fees

The fees charged by third parties (telecom operators, partners, and data center operators) include the leased-line fee and indoor cable rental fee. For more information, consult the third party.

#### Pricing of dedicated access ports

Dedicated access port fees include an initial installation fee and a resource occupation fee, as shown in the following two tables.

# 2 Billing of peering connections

In the process of peering connection, Alibaba Cloud charges for the initiator instance but does not charge for the acceptor instance.

#### **Billing methods**

#### Peering connection fee

In the process of peering connection, Alibaba Cloud charges for the initiator instance but does not charge for the acceptor instance. The fee depends on the bandwidth of the initiator instance and the distance between the two instances. The fee of VPC interconnection in the same region is lower than that of VPC interconnection between different regions.

· Cross-region interconnections are charged according to the prices shown on the purchase page. If you have any problem, contact your customer manager.



Peering connections between the China (Beijing) region and the China (Zhangjiakou) region with bandwidth less than 2 Gb are free of charge before December 31, 2020.

· Same-region interconnections are charged according to the price listed in the following table. This fee will not be charged until December 31, 2020.

# 3 Billing of Express Cloud Connect instances

If you need to change the billing method, you can open a ticket.

- · Fees charged by Alibaba Cloud
  - A Subscription-billed service fee is charged by Alibaba Cloud for each month
    , and is calculated according to the bandwidth. No initial installation fee or
    resource occupation fee is charged.
  - Extra fees are incurred if you choose to use offline value-added Alibaba Cloud services, such as configuring online and offline networks, and connecting your on-premises data center with Alibaba Cloud.
- · Fees charged by third-parties

Third-party fees may be incurred due to such activities as cable installations. We recommend that you consult the associated third-party service provider for more details.

#### Expiration reminder and overdue payment

- You will receive notifications of instances that are approaching expiration 15 days,
   7 days, and 1 day before they expire.
- · If you do not renew your instances within 15 days after the instances expire, they are stopped and then released. Related resources and configurations are also cleared.
