# **1 Billing of physical connections**

The billing method of physical connections is Subscription.

#### **Billing method**

#### Peer connection fee

In the process of peering connection, Alibaba Cloud only charges fee on the initiator instance and does not charge the receiver instance. The fee is charged according to the bandwidth of the initiator instance and the distance between the two instances. The costs of VPC interconnection in the same region is lower than that of VPC interconnection across regions.

- For the prices of cross-region interconnection, take the price on the purchase page as standard . If you have any problem, contact your customer manager.
- For the prices of same-region interconnection, see the price in the following table. This fee is not charged until April 1, 2019.
