1 Overview

If you use a server in mainland China to host your website, you must complete ICP Filing.

If you want to host your website on an Alibaba Cloud ECS instance in any mainland China regions, you must apply for an ICP Filing through the [Alibaba Cloud ICP Filing system](#) (only available in Chinese) according to the [ICP Filing regulations](#) of the province where your business is registered. After your application is approved, you can configure your domain name resolution to direct your domain name to your Alibaba Cloud ECS instance.

You can carry out the following filing operations on the [Alibaba Cloud ICP Filing system](#) (only available in Chinese):

- [First ICP Filing](#)

Neither the license or certificate of the organization or individual (that is, the subject of the ICP Filing), nor the website domain name which directs to a mainland China Alibaba Cloud ECS instance, has been filed with the Ministry of Industry and Information Technology (MIIT). In this case, you must complete ICP Filing through the Alibaba Cloud Filing system.

- [Transfer an ICP Filing](#) (transfers an existing ICP Filing license to Alibaba Cloud)

If your domain name has already been filed through another service provider, and now you want to host your website on an Alibaba Cloud ECS instance in a mainland China region, you must transfer the ICP Filing to the Alibaba Cloud ICP Filing system. The transfer-in procedures for new Alibaba Cloud ICP Filing system users are slightly different from the transfer-in procedures for Alibaba Cloud ICP Filing system users who have ever filed through the Alibaba Cloud system.

- [Add a new website for ICP Filing \(for new Alibaba Cloud ICP Filing system users\)](#)

The license or certificate of the organization or individual (that is, the subject of the ICP Filing) has been filed with the MIIT through another service provider. However, a new website is hosted on an Alibaba Cloud ECS instance in a mainland China region, so you must file your new website domain names with the MIIT through Alibaba Cloud.

- [Add a new website for ICP Filing \(the previous filings are on Alibaba Cloud system\)](#)

The license or certificate of the organization or individual (that is, the subject of the ICP Filing) has been filed with MIIT through Alibaba Cloud, and you want to host a new website on an Alibaba Cloud ECS instance in a mainland China region.

- [ICP Filing information change](#)

If you have completed an ICP Filing through the Alibaba Cloud ICP Filing system, and want to edit the information of the filing subject (such as the name or license number of the organization) or the website (such as adding or removing a domain name), you can change the information on the Alibaba Cloud ICP Filing system.

- [Claim an ICP Filing](#)

You have successfully filed for ICP record with HiChina before June 2010, and the ICP Filing has never been transferred to other service providers or the new Alibaba Cloud ICP Filing system. Now, you must claim the ICP Filing.

- [Cancel an ICP Filing](#)

If you do not use your website filed through Alibaba Cloud, you must cancel the filing (of the subject/website) or cancel the ICP Filing transfer. If you want to cancel one of the multiple domain names bound to a website, delete this domain name by modifying the website information instead of canceling the ICP Filing of the website.

You apply for the [Public Security Bureau \(PSB\) Filing](#) and [ICP Commercial License](#) from the relevant authorities.

- **PSB Filing:** According to the “Protection and Management Regulations for Computer Information Network and Internet Security” , within 30 days after opening a website, a PSB Filing application must be submitted through the [Security Management Service Platform of the National Public Security Authorities Website](#).
- **ICP Commercial License:** An online sales platform or third-party sales website for products or services must be with a business license from the local industrial and commercial administration, and an ICP Commercial License from the local communications administration. Contact your local authorities for the list of required documents and the filing procedure that you must follow. Go to the MIIT filing management system (www.miitbeian.gov.cn) for information about provincial administrations.

2 ICP Filing for the first time

An ICP Filing record is required to host a website on a mainland Chinese server. You can use the Alibaba Cloud ICP Filing system to apply for an ICP Filing.



Note:

The screenshots in this document describe the ICP Filing procedures for an enterprise. The ICP Filing subject can be an individual or an entity. Entities can include enterprises, public utilities, and organizations. All subjects share the same filing procedures. However, for personal website filings, please pay attention to the [personal website naming requirements](#).

Prerequisites

Before you apply for an ICP Filing, read [ICP Prepare for ICP Filing](#) and [ICP Filing procedures](#).

Procedures

1. Enter the required information to determine the ICP Filing type.

Log on to the [Alibaba Cloud ICP Filing system](#), enter a specified ICP Filing subject and a domain name, enter the CAPTCHA and click Verify Filing Type. The system automatically determines the filing type based on the information given.



Note:

- **Subject Region:** Select the region according to the location of the ICP Filing subject. The system automatically matches the local communications administration requirements based on the selected region.

- **Subject Type:** Choose a subject type for ICP Filing based on your requirements. For personal websites, select Personal.

2. Verify your Alibaba Cloud ECS instance.

For Product Type, select Alibaba Cloud and enter the ICP Filing Service Number. Click Verify.

3. Enter the subject information.

On the Subject Information page, enter the required information based on actual conditions. Click Next to enter the website information.



Note:

- For Subject Mailing Address, you can enter a certification address, office address or residential address.
- The Subject Document Address and the Subject Mailing Address must be in the same province.
- If you cannot provide a specific street number, you must provide an explanation in the remarks.
- Make sure the contact information you have provided is valid, including the email address and the phone number. If your contact information changes after

the filing is completed, update the filing information to prevent missing filing notifications.

4. Enter the website information.

On the Website Information page, enter the required information based on actual conditions. Click Next to upload the filing materials.



Note:

- **Website Name:** Follow the instructions on the right side to enter the website name. Some provinces have special requirements for personal website names. For more information, see [Personal website name requirements](#).
- **The Pre-Approval List is optional.** If your website involves any of the content types in the pre-approval list, consult the local authority and prepare the required documents.
- **If the website administrator is not the person applying for the ICP Filing,** click **Add New Administrator** in the **Website Administrator Information** column. The website administrator must take a photo as required and upload the photo for verification.

For filing applications made by entities, check if the local authority requires the applicant and the website administrator to be the legal representatives of the entities. See [ICP Filing regulations](#) of the place of ICP license issue. The application requirements vary by province, autonomous region, and direct-administered municipality.

- **If you have other websites to file,** click **Save**, and **Add Another Website**.

5. Upload the required materials.

Follow the instructions to upload copies of the required materials. Click Submit.

- Download the authenticity statement, and fill in the statement with a black pen. Upload the scanned copy or a photo of the statement. The authenticity statement requirements vary according to region and ICP Filing type. For more information, see [Notes on authenticity statements](#).
- You can [use the Alibaba Cloud app to upload documents and verify the website administrator with photos](#), if you apply for a filing in Guangdong, Chongqing, Liaoning, Anhui, and Fujian.

- If the local authority requires domain name certificates, contact your domain name service provider for the domain name certificates.

6. Submit the application to Alibaba Cloud. The submitted application will be reviewed within one working day. Make sure your phone number is in service and you answer the phone call to verify information from service staff.
7. Upload a photo for verification.

After you pass the initial review, log on to the [Alibaba Cloud ICP Filing system](#) to upload a photo of the website administrator for verification. The photo verification methods vary by region.

Users in Shanghai	ICP Filing applicants in Shanghai must use the Shanghai Communications Administration app to verify the website administrator. For more information, see Use the Shanghai Communications Administration app to verify the website administrator .

8. Text message verification (Optional).

According to the Ministry of Industry and Information Technology (MIIT), the pilot provinces for text verification are as follows: Tianjin, Gansu, Tibet, Ningxia, Hainan, Xinjiang, Qinghai, Zhejiang, Sichuan, Fujian, Shaanxi, Chongqing, Guangxi, Yunnan, Shandong, Henan, Anhui, Hunan, Shanxi, Heilongjiang, Inner Mongolia, and Hubei. The applicant must complete text verification before the application is submitted to the communications administration for review. Text verification is optional in other provinces. Check the text verification code sent by the MIIT. Follow the instructions to log on to the communications administration website to complete the verification.

- The review process usually takes 3 to 20 working days after your application documents are submitted.



Note:

- After your ICP Filing information passes the communications administration review, it will take a while before the review information is uploaded to the Alibaba Cloud ICP Filing system.
- During this period, you can check for website vulnerabilities and block malicious attackers. You can also check website content to avoid the risks of being shut down and blacklisted by the MIIT for not abiding to Chinese content law. For more information, see [Website Threat Inspector](#).

3 Transfer ICP Filings

If you have filed a website domain name ICP Filing through another service provider, you must transfer this application to Alibaba Cloud web hosting or set Alibaba Cloud as your server provider.

Alibaba Cloud provides two types of ICP Filing transfer:

- *Transfer an external ICP Filing*: The ICP Filing subject has never been filed through the Alibaba Cloud ICP Filing
- *Continue to transfer an ICP Filing*: The ICP Filing subject was filed through the Alibaba Cloud ICP Filing system.

Note

- When you transfer an existing ICP Filing to Alibaba Cloud, Alibaba Cloud is added as a service provider. You cannot modify the filed information during the transfer.
- Your ICP Filing data with the previous service provider is unaffected. You can use both service provider servers.
- You must follow the local *ICP Filing regulations* when entering the filing information and uploading the required documents.
- If you have submitted an ICP Filing subject to Alibaba Cloud, but want to transfer the subject's domain name from another service provider to Alibaba Cloud, log on to the Alibaba Cloud ICP Filing system using the account that submitted the initial ICP Filing and update your submission to include the domain name.
- If you use the HiChina ICP Filing platform, you need to import your ICP Filing information to the Alibaba Cloud ICP Filing system first. For more information about the importing procedures, see *Alibaba Cloud ICP Filing system FAQs*.
- If you change the filing subject or the website administrator after the ICP Filing transfer is completed, update the filing information in time.

You must follow the message to verify your mobile phone number within 48 hours . If you have not finish the verification in 48 hours, your ICP Filing application will be rejected.

For more information about mobile phone number verification, see [Mobile phone number verification for ICP Filing](#).

The local communications administration may take 3 to 20 workdays to review your ICP Filing information.。

The review result is sent to you by a text message and an email. You can view your ICP Filing status on the [ICP Filing system](#) .

7 Cancel an ICP Filing

If the domain name you have ICP filed through Alibaba Cloud is not in use, or your new domain name already has an ICP Filing number, you must log on to the Alibaba Cloud ICP Filing system to cancel ICP Filing. After the ICP Filing is cancelled, you can apply for another ICP Filing for the domain name.

If you are the ICP Filing subject, you can [Cancel an ICP Filing on Alibaba Cloud](#).

If you are not the ICP Filing subject, or you cannot cancel it online for some reason, you visit the local communication administration website to download the application form, and then [Cancel an ICP Filing directly through MIIT](#).

For the ICP Filing information of the domain name, you can query it on the Public Query page of the MIIT system (www.miitbeian.gov.cn).

Types of ICP Filing cancellation

The two types of ICP Filing cancellation are *Cancel Subject* and *Cancel Website*.

- *Cancel Subject*: Deletes the ICP number and all the websites filed under the ICP number.
- *Cancel Website*: Deletes an ICP Filing of a certain website.



Note:

If you want to cancel a domain name of a website which has multiple domain names, do not click *Cancel Website*, but click *Change Website Information* to delete domain names in the domain name list.

After the ICP Filing of the domain name has been cancelled, the website cannot be accessed.

Cancel an ICP Filing on Alibaba Cloud

1. Log on to the [ICP Filing system](#) (only available in Chinese).
2. Click *Cancel Subject* or *Cancel Website* on your ICP Filing information page.



Note:

If the buttons are not displayed, it may be because that you have another ICP Filing order in process. You must finish this order or withdraw it before submitting an cancelling application.

Once the application has passed the local communications administration review , the ICP Filing is cancelled.

Cancel an ICP Filing directly through MIIT

If you cannot cancel your ICP Filing on Alibaba Cloud, you can cancel ICP Filing on the communications administration website (only available in Chinese). Submit the application form along with your identification documents to the local communications administration. The application form shows the method to submit your identification documents. Once the application has passed the local communications administration review , the ICP Filing is cancelled. After the ICP Filing is cancelled, you can apply for another ICP Filing for the domain name.

If you forget your ICP Filing password, you can retrieve it from the MIIT website. See [How can I retrieve my MIIT ICP Filing password.](#)

8 PSB Filing FAQs

After ICP Filing, you must apply for PSB Filing.

You must log on to the [Internet Security Administration Service Platform of the National Public Security Bureau of China](#) (available in Chinese only) and submit an Public Security Bureau (PSB) ICP registration application within 30 days since you open the website, which already has an MIIT ICP number, for public visit.

After your PSB filing is successful, you must log on to the [Internet Security Administration Service Platform of the National Public Security Bureau of China](#) (available in Chinese only) .

On the File Website page, copy the PSB Filing Number and HTLM Filing Code , and download the Filing Code Icon. You must display them on the homepage of your website.

Guide of Public Security

Download the "Guide for PSB Filing" from the [PSB Filing system](#) (available in Chinese only).

For how to enter PSB Filing information, see [PSB Filing FAQs](#).

Handle illegal information

Carefully read and follow the rules and regulations mentioned on the [PSB Filing website](#) .

According to Chinese regulations governing PSB Filing, any illegal information presented on any websites must be immediately removed. Once illegal information is detected on a website hosted in an Alibaba Cloud instance, Alibaba Cloud notifies the client to remove the illegal information. If the client does not respond, the service is suspended without any refund.

Alibaba Cloud suspends the website services without any refund in the following cases:

- If a website is found to involve illegal information and violate the rule of posting illegal information for more than three times within 24 hours, Alibaba Cloud notifies the website owner by phone of the website shutdown and instance service suspension without any refund.

- If the client cannot be contacted within one hour after the illegal information is detected, the website is suspended and cannot resume service for 12 hours. If such situation occurs for three times, Alibaba Cloud suspends the client' s service without any refund.
- If the client has provided false information during PSB Filing (for example, fake phone number or email address), Alibaba Cloud shuts down the client' s website and suspends the client' s service without any refund.
- If the client does not delete the illegal information after receiving the phone call from Alibaba Cloud, Alibaba Cloud shuts down the website and suspends the client' s service without any refund.

9 ICP Commercial License filing links

If the website is an e-commercial platform, you must apply for an ICP Commercial License from the local authorities.

How to apply for an ICP Commercial License?

An ICP Commercial License is required for e-commercial platforms. Before you apply for an ICP Commercial License, you must have an ICP Filing number (that is Filing). For ICP Commercial License, go to the competent authority and complete the procedure, and your service provider can assist you by providing their qualifications and service agreement. For more information, visit the local communications administration websites.

Requirements for IP address

Some local authorities have special requirements on IP addresses when you apply for an ICP Commercial License.

Beijing: The IP addresses on the contract, website IP addresses, and filing IP addresses must be the same, and must be IP addresses in Beijing.

Guangdong (excluding Shenzhen): The IP addresses on the contract, websites IP addresses, and filing IP addresses must be IP addresses in Guangdong. Shenzhen has no special requirements.

Liaoning: The IP addresses on the contract, websites IP addresses, and filing IP addresses must be the same.

Shanghai and Hebei Province: The IP addresses in the contract must be the actual IP addresses of websites.

If you want to change your IP addresses, you must modify the filing information. Log on to [Alibaba Cloud ICP Filing system](#), click Modify ICP Filing information to update the information, and note that "Change IP address to XXXX. The data center is XXXX" in remarks. Submit the order for review. Then finish all the ICP Filing information modification procedures.

10 Apply for ICP Filing service numbers

The ICP Filing service number can associate the website to be filed with the cloud server that hosts the website. When you apply for an ICP Filing in the Alibaba Cloud ICP Filing Management console, an ICP filing service number is required for each website.

You can apply for an ICP Filing service number using one of the following methods:

- (Recommended) Log on to the [Alibaba Cloud ICP Filing Management console](#) with the same account you used to purchase your Alibaba Cloud ECS instance. The system automatically generates and associates a service number with the server.
- Apply for an ICP Filing service number manually, and log on to the [Alibaba Cloud ICP Filing Management console](#) for filing.



Note:

Regardless of the filing method used, the number of websites that can be filed per server remains the same.

Restrictions

If the website server is an ECS instance in mainland China, you need to apply a service number during the ICP Filing application. The ECS instances that you apply a service number for must meet the following requirements:

Location	Purchased instance duration	ICP Filing service numbers	Description
Mainland China	ECS instances with a public network bandwidth and a minimum three-month subscription	You can apply for at most five service numbers for each ECS instance.	The Alibaba Cloud ICP Filing system does not support Pay-As-You-Go instances.

Note:

- If the remaining subscription period is less than three months, renew the subscription to meet the requirements.
- You can only use one service number once. A service number becomes invalid after the ICP Filing is completed. You cannot use the service number for another website domain name filing.

Procedures

1. Log on to the [Alibaba Cloud ICP Filing Management console](#) with the initial account used for purchasing the Alibaba Cloud ECS instance.
2. On the ICP Filing Management page, click ICP No. Application in the left-side navigation pane.



3. Locate the instance that you want to apply for an ICP Filing service number, and click Apply in the information column of the instance.



Note:

If the button Apply is not displayed, it indicates this instance does not meet the filing requirements. For more information, see [ICP Filing service number FAQs](#).

4. In the dialog box that appears, click OK.



Note:

Once your application is completed, you can check the service number in ICP No. Management on the ICP Filing Management page.

11 SMS message verification for ICP Filing

China's Ministry of Industry and Information Technology (MIIT) has selected several provinces and municipalities for the pilot project of SMS message verification for ICP Filing. After users in those provinces and municipalities apply for ICP Filing on the Alibaba Cloud ICP Filing platform, they need to complete SMS message verification so that their filing applications can be accepted by administration offices.

Provinces that require SMS message verification

Users in the following provinces and municipalities are required to complete SMS message verification after applying for ICP Filing on the Alibaba Cloud ICP Filing platform:

From December 18, 2017, [Tianjin](#), [Gansu](#), [Tibet](#), [Ningxia](#), [Hainan](#), [Xinjiang](#), and [Qinghai](#) are listed as pilot provinces.

From September 10, 2018, [Zhejiang](#), [Sichuan](#), [Fujian](#), [Shaanxi](#), [Chongqing](#), [Guangxi](#), and [Yunnan](#) are listed as pilot provinces.

From September 24, 2018, [Shandong](#), [Henan](#), [Anhui](#), [Hunan](#), [Shanxi](#), [Heilongjiang](#), [Inner Mongolia](#), and [Hubei](#) are listed as pilot provinces.

Verification code transmission

- The verification code is only sent to the mobile number entered in the Contact method 1 field in the filing information.
- If this mobile number has been changed in the filing information, the verification code is sent to the new mobile number.
- The verification code is a six-digit number.
- After receiving a notification stating that Alibaba Cloud has submitted your filing information to the communications administration office, you will receive the verification SMS message in about five minutes.

Verification code validity period

You need to visit the provincial administration website to perform verification within 24 hours. After you complete SMS message verification for your mobile phone, your filing information is transferred to the administration office for review.

If you fail to complete the verification within 24 hours or the verification fails, your filing information is automatically returned. There are two scenarios in this case:

- Scenario 1: If your filing information has not been modified and it meets the current requirements, click Submit ICP Filing on the ICP Filing platform to directly enter the SMS message verification process.
- Scenario 2: If your filing information or materials do not meet the current requirements, you must modify it, re-submit the filing application, and enter the SMS message verification process again after review by Alibaba Cloud.

Verification code transmission number

The codes sent to users of China Telecom, China Unicom, and China Mobile are sent by a fixed number. There is no fixed number for transmission of verification codes to users of virtual providers.

SMS message verification process

After the SMS message containing the verification code is sent from the MIIT to the mobile number to be verified, log on to the website of the provincial or municipal authority (only available in Chinese) promptly and complete the SMS message verification.

1. Visit the [provincial or municipal administration website](#) for your ICP Filing, and click ICP Filing SMS Message Verification in the lower-right corner of the home page.



2. Enter your verification code, mobile number, and the [last six digits of your ID card number](#). Complete the verification and then click Submit. When you pass the verification, the system displays a prompt stating that the verification is

completed. If another mobile number in your ICP Filing order must be verified, repeat this process.

Note:

- If the information that you entered is incorrect, or any of the entries (the verification code, mobile number, and *last six digits of your ID card number*) does not match, you cannot retrieve the corresponding order. Then, the system

will display a prompt that it cannot find the record. In this case, check the information and try again.



- If you enter the incorrect ID number for five times consecutively, the system displays a prompt that the verification fails. In this case, your ICP Filing application is rejected by the MIIT system.



SMS message resending process

If you do not receive a verification SMS message from the MIIT, you can request that the SMS message be resent.

1. Log on to the [provincial or municipal website](#) for your ICP Filing.
2. Click Filing SMS Message Verification.



3. Click Resend SMS Message.

4. Fill in the mobile number and the [last six digits of your ID card number](#), and complete image splice verification.

5. Click Submit.
6. Check your mobile phone to get the verification code, and then complete the verification on the website.

13 Using Shanghai Communications Administration app to verify the website administrator

Shanghai Communications Administration requires that ICP Filing applicants in Shanghai must use Shanghai Communications Administration app (only available in Chinese) to verify the website administrator.

Shanghai Communications Administration also requires that the photo for verification must be taken in Shanghai, and the mobile phone number used in verification is the mobile phone number of the website administrator in the ICP Filing information.

Allow the app to access your location when installing it.

The procedure is as follows:

1. After your ICP Filing information passes Alibaba Cloud review, log on to the [ICP Filing system](#), and use the mobile phone app to scan the QR code on the page (We recommend you use Alipay or DingTalk to scan the QR code. Scanning with WeChat is not supported) to download the installation file.

2. Open the app on your phone and tap Verify Now.**3. Verify the mobile phone number. Enter the mobile phone number of the website administrator that is the same as in the ICP Filing information, enter the verification code received in the mobile phone, and tap Mobile Phone Verification.**

4. Verify the ID card of the website administrator. Tap Document Acquisition and take photos of the front and back sides of the ID card.



5. Take a photo with the ID card in hands. The photo must show the full face with clear facial features and the ID card clearly.



6. Go to the [ICP Filing system](#) on your computer to confirm the photos. Enter the Picture Code displayed on the mobile phone, and then the ICP Filing system displays the

photos you have taken with the app. If you have no problems with the photos, click Confirm.



After you successfully submit the photos for verification, Alibaba Cloud reviews it within one business day. If it passes the review, Alibaba Cloud submits your ICP Filing information to the communications administration.
