1 File system

You can perform all kinds of operations on a file system on the NAS console, such as using the file system list, checking detailed information about a file system instance, and deleting a file system.


Prerequisites

Before you using a file system, you must:

- 1. Log on to the NAS console.
- 2. Create a file system, or ensure one or more file system has been created.

Use the file system list

You can click File System List on the left panel to view the file system list page.




In the list, you can edit the File System Name, Add Mount Point to a file system, and Manage or Delete a file system.

Check the details of a file system instance

Click the File System ID of an instance or click Manage on the right of an instance to view the File System Details page.

The details page include the following information:

- · Basic inforation about the file system, such as the file system ID, region, zone, and file system usage
- · Mount point list of the file system, in which you can manage the mount points of the file system.

Delete a file system

You can click Delete on the right of a file system instance to delete it.

- · Once a file system is deleted, the data cannot be recovered. Take care when you perform this operation.
