1 Billing method

Fees for NAT Gateway are incurred when you create NAT Gateway instances and when traffic is sent over the Internet (that is, the NAT Gateway is associated with one or more Elastic IP Addresses (EIPs) to allow access to the Internet).

Instance fee

· Billing method

NAT Gateway is billed by the Pay-As-You-Go method and fees are calculated and charged on a daily basis.

· Billing item

Only an instance fee is charged at the creation of NAT Gateway.

· Price

The fee for NAT Gateway varies according to the selected specification.

Internet fee

After you create an NAT Gateway, you need to associate one or more EIPs with the NAT Gateway so that the NAT Gateway can access the Internet. After the association, an Internet fee is incurred due to traffic being sent over the Internet. The Internet fee is billed to the associated EIP, instead of the NAT Gateway.



Note:

If you purchased a shared bandwidth package for your account before January 26, 2018, you can still use the public IP address of the bandwidth package. In this case, the Internet fee is billed to the bandwidth package. For more information, see *Billing* of NAT bandwidth package.

2 Billing method

NAT Gateway instances support the Pay-As-You-Go billing method. A Pay-As-You-Go NAT Gateway instance can be released at any time.

Billing items

The fee of a Pay-As-You-Go NAT Gateway instance = unit instance price (USD/day) \times duration of usage

- The instance usage duration is measured from the time at which the instance was created to when it was released. Both the billing cycle and bill cycle are on a daily basis.
- · Different NAT Gateway specifications are provided to meet different demands. The instance fee varies by specification.
- · If you change the specification of an instance during its billing cycle, the instance fee is billed according to the highest specification.
