### 1 Billing method

Security Center Advanced and Enterprise Edition are billed by month or annual subscription.

### **Billing period**

You are billed for the validity period specified in your subscription.

#### Bill calculation

Bill= (Number of billable assets \* Price of protecting one server for validity period + Price of value-added functions \* Number/Volumn of the value-added functions) \* Validity period of subscription.

- Number of assets: Refers to the number of billable assets that require Security Center's protection, including ECS instances and external servers. The default Number of assets is the number of ECS instances you own, and the number of assets that you specify cannot be less than the number of your ECS instances.
- · Value-added functions: The value-added functions provided by Security Center must be additionally purchased, such as Log Analysis service .
- · Price of protecting one server: You could check the detailed price of protecting one server and the value-added functions on Security Center purchase page.



#### Note:

Security Center also protects assets such as SLB and NAT gateways. However, Security Center only charges for protecting your ECS instances and external servers. All other assets are currently protected free of charge.

### 2 Purchase Security Center

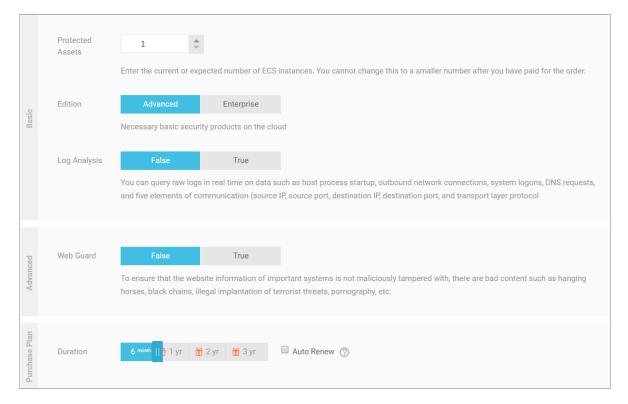
Security Center Advanced and Enterprise Edition provide comprehensive security monitoring and diagnosis services for your assets on the cloud. You can purchase Advanced and Enterprise Edition by Subscription.

#### Context

Before you start, refer to #unique\_7 to check the features provided by different Editions.

### **Procedure**

- 1. Log on to your Alibaba Cloud account, and go to the Security Center purchase page
- 2. Configure your required Security Center.



Protected Assets: The number of assets (ECS instances and external servers)
needs to be protected by Security Center. By default, the purchase page displays
the number of ECS instances you have. You cannot specify a number that is less
than the default number.

If you predict that your number of servers may increase within the validity period of your subscription, specify the predicted number of servers you will need Security Center to protect in your total number of assets.

- Edition: Advanced Edition is selected by default. For more information on the differences between Advanced Edition and Enterprise Edition, refer to Security Center features.
- · Log Analysis: Log Analysis is the value-added service of Security Center.

  Backtracing and security analysis are provided for ten types of security logs, such as server logs and network logs.
- Web Guard: Web Guard is the value-added service of Security Center. It can ensure your website is not maliciously tampered with illegal information, such as terrorist threats, gambling, etc.
- 3. Select a Duration and select Auto-renew if you want to enable automatic renewal.



### Note:

- The minimum subscription duration is determined by the number of assets you want to protect:
  - If you have less than 10 assets, you must purchase at least a six-month subscription.
  - If you have more than 10 assets, you must purchase at least a one-month subscription.
- · If you enable Auto-renew, the automatic renewal cycle is aligned with the validity duration of your subscription. For example, if your subscription is monthly, the automatic renewal cycle is one month. If your subscription is yearly, the automatic renewal cycle is one year.
- 4. Click Buy Now and complete payment.

### 3 Renewal and upgrade

If you are using Advanced or Enterprise Edition of Security Center, we recommend that you renew your Security Center subscription before its expiration date to ensure the availability of the service. If the number of assets under your account is 120% of the number of assets configured for your current subscription, you must upgrade your subscription by specifying the larger number of assets and pay the additional fees to continue with your current subscription.

### **Expiration**

One week before your Security Center subscription expires, Security Center sends you a message reminding you to renew your subscription. If you do not renew your subscription before it expires, your assets are no longer protected by Security Center starting from the first day after the expiration date.

For three days after the expiration date, Security Center retains all your configurat ions and data, such as your asset groups, tags, quarantined files, vulnerability whitelist, baseline check policies and baseline check whitelist, and asset fingerprin ts. You must renew your Security Center subscription within the three days to retain your configurations and data.

If you do not renew your subscription within three days of your Security Center subscription expiration date, your Security Center configurations and data are removed. You must purchase a new Security Center Advanced or Enterprise Edition subscription to resume use of Security Center.

### **Renew Security Center Enterprise Edition**

- 1. Log on to the Security Center console.
- 2. In the upper-right corner, click Renew.
- 3. Confirm your order details and select your required validity.



Note:

You cannot change the number of assets to be protected by Security Center during a subscription renewal.

### Upgrade

When upgrading your Security Center subscription, you must specify at least the actual number of billable assets, that is, the total number of ECS instances and external servers under your account. You cannot specify a number that is less than that. If you predict that the number of billable assets may increase within the validity period of your subscription, you must specify the predicted number of servers you will need Security Center to protect as your total number of assets.

During the subscription period of your Security Center Enterprise Edition, if the number of servers under your account is more than 120% of the number of assets configured for your current subscription, the system notifies you of an upgrade required to your Security Center subscription. If this occurs, you must upgrade your Security Center subscription to continue using the service.

For example, if the number of assets configured for your Security Center Enterprise Edition subscription is 10, but you now have 13 servers under your account, you must configure the number of assets as 13 and pay the additional fees generated for the three extra servers to continue using Security Center.

### **Upgrade Security Center**

- 1. Log on to the Security Center console.
- 2. In the upper-right corner of the Overview page, click Upgrade.



### Note:

The Upgrade button only displays on the Overview page when the number of billable assets under your account is 120% of the number of billable assets configured for your current subscription.

- 3. Specify the number of assets that you want Security Center to protect, and click Pay Now.
- 4. Complete payment.
