1.0verview

This topic provides an overview of the preparations that you must make before you apply for an Internet Content Provider (ICP) filing. For a quick approval of an ICP filing, we recommend that you make preparations in advance.

Read and understand ICP filing regulations

The communications administrations (hereinafter referred to as authorities) in different provinces, autonomous regions, and municipalities have different regulations and require different materials for an ICP filing application. We recommend that you read and understand the ICP filing regulations of different provinces, autonomous regions, and municipalities. For more information, see ICP filing regulations of MIIT for different regions or visit the Failed to resolve content from t159730.dita#concept_185492/xref_hws_dm0_ijk.

Prepare and check the domain name

You must provide the domain name of your website when you apply for an ICP filing. Your domain name must meet the following requirements:

- The top-level domain name is approved by the Ministry of Industry and Information Technology (MIIT).
- The domain name is valid for more than three months. The authorities in specific provinces, autonomous regions, and municipalities require that the domain name be valid for more than 45 days.
- The domain name registrar is approved by the MIT.

? Note The Alibaba Cloud international site (alibabacloud.com) provides registration services only for internationalized domain names. Such domain names must meet the following requirements:

- From January 1, 2018, if your domain names are registered at international domain name registrars such as the Alibaba Cloud international site (alibabacloud.com), you must transfer the domain names to registrars in mainland China and complete real-name verification before you apply for an ICP filing. For more information about how to transfer a domain name to the Domains service of the Alibaba Cloud China site (aliyun.com), see Transfer a domain name to Alibaba CloudTransfer a domain name to Alibaba Cloud.
- Specific domain names that were registered before January 1, 2018 at international domain name registrars, such as the Alibaba Cloud international site (alibabacloud.com), may have obtained an ICP filing. In this case, you do not need to transfer these domain names.
- For an ICP filing application from an individual, the domain name registrant must be the individual. For an ICP filing application from an organization or an enterprise, the registrant can be a shareholder, the major principal, or a senior executive of the organization or enterprise.
- Real-name verification is passed for the domain name.

? Note If real-name verification is not complete, or the real-name verification information is inconsistent with the ICP filing entity information, the ICP filing application may not be submitted or may fail the review. You must submit the required ICP filing information based on the regulations of the local authorities. For more information, see ICP filing regulations of MIIT in different regions.

• The entity information provided during the ICP filing application must be consistent with the realname verification information of the domain name registrant. Such information includes the name, certificate type, and certificate number.

For more information about how to prepare and check your domain name, see Prepare and check the domain name.

Purchase and prepare an instance

To apply for an ICP filing by using the Alibaba Cloud ICP Filing system, you must purchase an Alibaba Cloud instance in . If your websites are hosted on the instances of Alibaba Cloud services listed in the following table, you can apply for ICP filings for your websites.

? Note

- If the duration that remains before your subscription Elastic Compute Service (ECS) instance or Elastic Web Hosting instance expires does not meet the requirements of the ICP filing application, you must renew your instance before you apply for an ICP filing.
- You can apply only for a limited quantity of service identification numbers for each instance. You cannot renew an instance to increase the upper limit. If the quantity of service identification numbers that you have applied for reaches the upper limit, you must purchase another instance for more service identification numbers.

You must prepare and upload an electronic copy or a color photo of the following materials:

You are required to upload the identity document only once in the Alibaba Cloud ICP Filing system.

Certificate of change	If the ICP filing entity is an organization or an enterprise, and the organization or enterprise name is changed, you must provide a certificate of change that is issued by the corresponding industry and commerce administration when you apply for an ICP filing.

Material type	Scenario
Certificate of employment	If the certificate number of an entity leader or a website administrator appears in the ICP filing information of multiple organizations, enterprises, or individuals, specific provincial authorities, such as the Sichuan provincial authority, require that you provide a certificate of employment of the entity leader or website administrator.
Business statement	The name, business scope, website name, or website remarks of an organization or an enterprise in the Sichuan province may contain commerce-related terms, and such organization or enterprise may not be required to obtain an ICP commercial license as notified by the local authority. In this case, a business statement of the organization or enterprise must be provided for an ICP filing application.

Create an Alibaba Cloud account

You need to use an Alibaba Cloud account to apply for an ICP filing in the Alibaba Cloud ICP Filing system. Therefore, we recommend that you prepare and create an Alibaba Cloud account in advance to apply for an ICP filing. For more information, see Register an Alibaba Cloud account.

Obtain a pre-approval (Optional)

If your website involves information about special industries, such as news, publishing, medicine, or medical devices, you must obtain a pre-approval before you apply for an ICP filing. You must also provide the required pre-approval documents during the ICP filing application.

For more information about the industries that require pre-approvals and relevant instructions, see Preapproval.

2.Register an Alibaba Cloud account

This topic provides you with the considerations and suggestions for registering an Alibaba Cloud account before you apply for an Internet Content Provider (ICP) filing. The Alibaba Cloud ICP Filing system allows you to apply for an ICP filing, modify ICP filing information, cancel an ICP filing, and claim an ICP filing. To use the Alibaba Cloud ICP Filing system to apply for an ICP filing, you must first register an Alibaba Cloud account based on the entity information and actual needs. You can log on to the Alibaba Cloud ICP Filing system with your Alibaba Cloud account to manage the ICP filing information.

Considerations for Alibaba Cloud account registration

• Each Alibaba Cloud account can be used to apply for ICP filings for one entity (organization or individual) only. However, each entity can apply for ICP filings for multiple websites.

If you need to apply for ICP filings for multiple entities, you must register multiple Alibaba Cloud accounts. We recommend that you register an Alibaba Cloud account for each entity, and use the corresponding account to apply for and manage ICP filings for all websites of the entity.

• The Alibaba Cloud account used to apply for and manage an ICP filing can be different from the one used to purchase Alibaba Cloud instances.

If your Alibaba Cloud instances and ICP filing information are managed by different administrators, we recommend that you use separate Alibaba Cloud accounts to manage the instances and ICP filing information.

If the account that you use to apply for an ICP filing is different from the account to which the instance for hosting the corresponding website belongs, log on to the Alibaba Cloud Management Console by using the credentials of the account to which the instance belongs and obtain a service identification number. For more information, see Apply for service identification numbers. During an ICP filing application, you need to enter the service identification number to complete the verification of the instance.

Suggestions for planning accounts

We recommend that you register sufficient accounts at the Alibaba Cloud China site (aliyun.com) before you apply for ICP filings. You can use these accounts to apply for ICP filings both from a PC and from the Alibaba Cloud app, which is convenient for the management of your ICP filing information.

- If you use accounts registered at the Alibaba Cloud China site (aliyun.com), you can apply for ICP filings both from a PC and from the Alibaba Cloud app. If you apply for an ICP filing from a PC, when you upload the ICP filing materials, you must download the Alibaba Cloud app, and use the Alibaba Cloud app to scan the QR code on the uploading page and to upload the materials. You do not need to log on to the Alibaba Cloud app.
- If you use accounts registered at the Alibaba Cloud international site (alibabacloud.com), you can only apply for ICP filings from a PC. In this case,

• For Taobao shops or enterprise websites, you can apply for ICP filings and manage ICP filing information from a PC with your accounts registered at the Alibaba Cloud China site (aliyun.com) or

international site (alibabacloud.com). For more information, see Apply for an ICP filing for a Taobao shop or an enterprise website in .

Register an account

Register one or more Alibaba Cloud accounts based on your actual needs. For more information, see Create an Alibaba Cloud account.



3.Notification settings about ICP filing status changes

During the application process of an Internet Content Provider (ICP) filing and after the ICP filing is obtained, Alibaba Cloud will notify specified users by using multiple channels about the progress, status change result, and review result for specific items. We recommend that you determine the contacts and receiving channels of notifications and finish the settings in advance by reference to this topic before you start to apply for an ICP filing. This ensures that the ICP filing application progress will not be affected by delayed receipt of notifications.

Context

During the application process of an ICP filing and after the ICP filing is obtained, Alibaba Cloud will notify the ICP filing owner and ICP filing contacts by using emails and internal messages about the application review result, application result, and review result for specific items. Before you apply for an ICP filing, you must determine the contacts and receiving channels of notifications in advance on the Message Center page. This ensures that you will not miss notifications, which may affect subsequent ICP filing application operations.



Set notification receiving channels

4.Prepare and check the domain name

This topic describes how to check the domain name of your website. Before you apply for an Internet Content Provider (ICP) filing, you must prepare and check the domain name of your website to ensure that the domain name meets the requirements for an ICP filing application. This helps you pass the verification of the local communications administration and the Ministry of Industry and Information Technology (MIIT) to obtain an ICP filing with efficiency.

(?) Note If your domain name is not registered with Alibaba Cloud, but your website is hosted on an Alibaba Cloud instance in , you can apply for an ICP filing in the Alibaba Cloud ICP Filing system. Before you apply for an ICP filing for your domain name, make sure that the domain name meets the requirements.

Check whether your domain name meets requirements based on the following items:

- Check it em 1: Check the real-name verification information of the domain name
- Check it em 2: Check whet her your domain name is qualified for an ICP filing application
- Check item 3: Check whether your domain name registrar is approved by the MIIT

Check the real-name verification information of the domain name

You cannot apply for an ICP filing for domain names that have not passed real-name verification. Make sure that you have completed real-name verification for your domain name and the real-name verification information is consistent with the ICP filing information. The ICP filling application fails if inconsistent information exists.

- If your domain name is not registered with Alibaba Cloud, you must contact your domain name registrar to obtain the real-name verification information.
- If your domain name is registered with Alibaba Cloud, perform the following steps to view the realname verification information of your domain name:

(?) Note The Alibaba Cloud International site (alibabacloud.com) provides registration services only for internationalized domain names. Such domain names must meet the following requirements:

- From January 1, 2018, if your domain names are registered at international domain name registrars such as the Alibaba Cloud International site (alibabacloud.com), you must transfer the domain names to registrars in the Chinese mainland and complete the realname verification before you apply for an ICP filing. For more information about how to transfer a domain name to the Domains service on the Alibaba Cloud China site (aliyun.com), see Transfer a domain name to Alibaba CloudTransfer a domain name to Alibaba Cloud.
- Specific domain names that were registered before January 1, 2018 at international domain name registrars, such as the Alibaba Cloud International site (alibabacloud.com), may have obtained an ICP filing. In this case, you do not need to transfer these domain names.
- 1. View the real-name verification information.

Note If you cannot find your desired domain name, the domain name may belong to another Alibaba Cloud account. You must obtain the account to which the domain name belongs.

- iii. On the **Basic Information** page, view the real-name verification information of the domain name.
- 2. Optional. Transfer the domain name.

The information of the registrant must be consistent with that of the ICP filing entity. The information includes the name, certificate type, and certificate number. If the registrant is not the ICP filing entity, you must transfer the domain name to the entity to ensure information consistency. For more information, see Transfer domain name ownership.

If the entity is an organization or an enterprise, and the registrant information such as the name, certificate type, or certificate number is inconsistent with the information of the entity, you can upload supporting documents to complete the ICP filing application. However, this is available only in specific provinces, autonomous regions, and municipalities. For more information about the regulations of communications administrations in different provinces, autonomous regions, and municipalities. For more information about the regulations, see ICP filing regulations of MIIT in different regions. For more information about the required supporting documents, see the Domain name registrant certificates topic in the .

3. Optional. Perform real-name verification.

Before you apply for an ICP filing, make sure that you have completed real-name verification for the domain name. For more information, see the Real-name verification for a domain name topic in the Domains documentation on the Alibaba Cloud China site (aliyun.com).

? Note After you complete real-name verification, the real-name verification information will be synchronized to the database of the local communications administration in about three days. We recommend that you submit the ICP filing application three days after the real-name verification of the domain name is complete. Otherwise, the ICP filing application may fail due to the lack of real-name verification information in the database of the local communications administration.

- 4. Optional. Renew the domain name.
 - ICP filings in Shanghai: Renew the domain name at least 180 days before it expires.
 - ICP filings outside Shanghai in China: Renew the domain name at least 90 days before it expires.

If your domain name does not meet the preceding requirements, we recommend that you renew the domain name before you apply for an ICP filing. For more information, see Renew a domain name.

Check whether your domain name is qualified for an ICP filing application

You cannot apply for an ICP filing for a domain name whose top-level domain name is not approved by the MIIT. An ICP filing is not required for country-code domain names or domain names that are hosted. Before you apply for an ICP filing, perform the following steps to check whether your domain name is qualified for an ICP filing application:

- 1. Check whether the domain name is approved by the MIIT.
 - i. Visit the MIIT website.
 - ii. In the left-side navigation pane, click China's Internet Domain Name System.



iii. View the top-level domain names approved by the MIIT on the **China's Internet Domain Name System** page.

You cannot apply for an ICP filing if the top-level domain name of your domain name is not included on the **China's Internet Domain Name System** page.

2. Check whet her the domain name is a second-level domain name.

If your website is hosted on an instance in , you must apply to the MIIT for an ICP filing for the domain name of your website. After the ICP filing for the top-level domain name is obtained, the second-level domain names and subdomains become accessible and no more ICP filing is required.

- If the ICP filing for your top-level domain name is not obtained by using the Alibaba Cloud Filing system, you must add Alibaba Cloud to the service provider list in the ICP filing information. You can add multiple service providers to the ICP filing information for a top-level domain name.
- Your website cannot provide services until the top-level domain name of your domain name obtains an ICP filing. After the top-level domain name of your domain name obtains an ICP filing, the second-level domain names and subdomains become accessible.

Check whether your domain name registrar is approved by the MIIT

If your domain name registrar is not approved by the MIIT, you must transfer the domain name to an approved registrar before you apply for an ICP filing. To view your registrar and transfer your domain name to Alibaba Cloud, perform the following steps:

1. View the information of the domain name registrar.

Visit the WHOIS page, enter the keywords in the search box, and then click **Search**. On the page that appears, you can view the information of the domain name registrar.

- 2. Check whether the registrar is approved by the MIT.
 - i. Visit the MIIT website.
 - ii. In the left-side navigation pane, click **Approved Domain Name Registrars**.

iii. In the **Company Name** column, view the approved domain name registrars, and check whether your domain name registrar is included.

If your domain name registrar is not included, you must transfer your domain name to a registrar that is approved by the MIIT. To transfer your domain name to Alibaba Cloud, go to the next step.

3. Optional. Transfer the domain name to a registrar that is approved by the MIIT.

For more information about how to transfer a domain name to Alibaba Cloud, see Transfer a domain name to Alibaba CloudTransfer a domain name to Alibaba Cloud.

5.Host instances and service providers

5.1. Prepare and check the instance and access information

If the instance that hosts your website is deployed in , you must apply for an Internet Content Provider (ICP) filing before you launch your website. During the process of an ICP filing application, Alibaba Cloud verifies the instance and access information. This topic shows you how to check the instance and access information before you apply for an ICP filing if your website is hosted on an Alibaba Cloud instance or a service from Alibaba Cloud Marketplace that is deployed in .

Check the following items to ensure that your instance and access information meet the requirements for applying for an ICP filing:

- Check it em 1: Check the access information
- Check it em 2: Check ot her Alibaba Cloud services
- Check item 3: Check changes in access information

Check the access information

During the application review process, information about the service provider, access method, instance location, and website IP address is verified.

If you host your website on a self-managed server or in a data center, you must contact an Internet service provider (ISP), such as China Telecom and China Unicom, to apply for an ICP filing.

If you host your website on an Alibaba Cloud instance, you can apply for an ICP filing in the Alibaba Cloud ICP Filing System. Make sure that the following conditions are met before you apply for an ICP filing:

Instance location

The instance is deployed in an Alibaba Cloud region in .

? Note

- To obtain the detailed endpoint of the instance, consult the after-sales team of Alibaba Cloud by using Smart Online.
- If the instance based on which you want to apply for an ICP filing is not an Alibaba Cloud instance, contact your service provider for the application.

• Instance service type

The instance is of the specified service type and meets the requirement on the subscription duration. For more information, see Supported instance service types and the maximum number of service identification numbers allowed. Note After you purchase an Alibaba Cloud instance that is deployed in , you must pay close attention to the expiration date and renew the instance at your earliest convenience. Otherwise, your website cannot be accessed and may be identified as a website whose ICP filing is invalid after the instance expires. If you do not promptly resolve this issue, the ICP filing will be canceled and your business will be affected.

• Number of service identification numbers available for websites

The number of service identification numbers that can be applied for per supported instance varies based on its service type. Make sure that the instance you purchased has sufficient unused service identification numbers for your websites. For more information, see Supported instance service types and the maximum number of service identification numbers allowed.

? Note

- If you use the same Alibaba Cloud account to purchase the instance and apply for an ICP filing, you can select the instance during the ICP filing application. You do not need to apply for a service identification number. You can directly select the instance or apply for a service identification number for an ICP filing application. No matter which method you choose, the maximum number of service identification numbers that are supported by an instance does not change.
- If you use different Alibaba Cloud accounts to purchase the instance and apply for an ICP filing, we recommend that you log on to the Alibaba Cloud Management Console and apply for a service identification number by using the account that is used to purchase the instance. For more information, see Apply for service identification numbers.
- To apply for an ICP filing, you must apply for a service identification number first. If a service identification number is already in use for a website, you cannot reuse it to apply for an ICP filing for another website. If you deregister the website or remove Alibaba Cloud from the service provider list, the service identification number is still considered used. You cannot reuse it to apply for an ICP filing for another website.

Check changes in access information

If the service provider or the instance IP address changes, perform the required operations as instructed in the following content.

- You may have obtained an ICP filing through Alibaba Cloud. To host your website on another Alibaba Cloud instance, perform the following operations based on the specific scenario:
 - If your website does not require a commercial ICP license, you need to modify only the resolution record of the domain name and direct the domain name to the new instance. You do not need to apply for a new ICP filing.
 - If the province where you obtained a commercial ICP license requires that the submitted IP address be the same as the actual IP address, you must modify the submitted IP address in the Alibaba Cloud ICP Filing system. Contact the local authority to check whether you are required to modify the IP address when you apply for a Public Security Bureau (PSB) filing or a commercial ICP license.

(?) Note If you have obtained an ICP filing through Alibaba Cloud and need to change the service provider, you must add the new service provider to the ICP filing information. For more information, consult the new service provider.

• If you have obtained an ICP filing for your website through another service provider and need to change the service provider or direct a subdomain to Alibaba Cloud, you must add Alibaba Cloud to the ICP filing information as a service provider.

5.2. Apply for service identification numbers

A service identification number associates the website for which you want to apply for an Internet Content Provider (ICP) filing with the instance that hosts the website. If you apply for an ICP filing in the Alibaba Cloud ICP Filing system, you must provide a service identification number for each website. The number of service identification numbers that you can obtain for each supported Alibaba Cloud instance varies based on its type. This topic describes how to apply for a service identification number after you purchase an instance.

Precautions

- You can apply for service identification numbers only for supported Alibaba Cloud instances. Service identification numbers are used to apply for ICP filings. For more information about the supported instances and the maximum number of service identification numbers, see Supported cloud services and maximum number of supported websites.
- If you use the same Alibaba Cloud account to purchase the instance and apply for an ICP filing, you can select the instance during the ICP filing application. You do not need to apply for a service identification number. You can directly select the instance or apply for a service identification number for an ICP filing application. No matter which method you choose, the maximum number of service identification numbers that are supported by an instance does not change.
- You may use different Alibaba Cloud accounts to purchase an instance and apply for an ICP filing. In this case, we recommend that you log on to the Alibaba Cloud Management Console by using the account that is used to purchase the instance and apply for a service identification number. For more information, see Procedure.
- To apply for an ICP filing, you must apply for a service identification number first. If a service identification number is already in use for a website, you cannot reuse it to apply for an ICP filing for another website. Apply for a service identification number for an instance provided by another service provider

You must submit an ICP filing application to the service provider of your instance. The instance that is provided by another provider can be a cloud server or an on-premises machine. If you purchase an instance from another service provider, you must apply to the service provider for a service identification number before you can apply for an ICP filing.

You must submit the related materials to apply for an ICP filing, and the authenticity of your materials is verified. After the verification is completed, your ICP filing information is reviewed first by the Ministry of Industry and Information Technology (MIIT) by using text messages and then the local Communications Administration.

Status of the service identification number

Log on to the ICP Filing Management console by using the Alibaba Cloud account that is used to purchase the instance. On the ICP No. Management page, you may view the service identification number in one of the following states: Bound, Filing in Progress, and Filed. The following table describes the states.

6.Required materials

To apply for an Internet Content Provider (ICP) filing for a website domain name, you must upload basic materials and necessary auxiliary materials by using the **Alibaba Cloud app**. Basic materials include the identity documents of the entity leader and the website administrator, and the certificates of the entity. Auxiliary materials can be selectively uploaded based on the scenario and regulations of the local authority. This topic describes the applicable scenarios and upload requirements for various materials during ICP filing applications. We recommend that you prepare the required materials in advance for a quick ICP filing application.

? Note

- The Ministry of Industry and Information Technology (MIIT) has requirements for authenticity verification. To meet the requirements, you must use the latest version of the Alibaba Cloud app to take photos of the identity documents and entity certificates that are required for ICP filing applications and then upload the photos. Facial recognition must be simultaneously performed to verify the authenticity of specific real-person data. You must not reproduce the photos of the identity documents or entity certificates that are stored on mobile phones or computers. Otherwise, your ICP filing application fails.
- If the entity leader is in a remote place, ask the entity leader to complete facial recognition for authenticity verification in this remote place. If the entity certificates are in a remote place, obtain the photos of the entity certificates and upload the photos.

ICP filing entity being an individual

If the ICP filing entity is an individual, you must provide the following basic materials and auxiliary materials based on actual conditions. Basic materials **must be provided**, whereas auxiliary materials can be selectively provided as requested by the local authority.

• Basic materials: You must prepare the original ID card of the ICP filing entity, and take and upload photos of the ID card by using the Alibaba Cloud app.

Entity certificates are the qualification documents of the entity, such as the business license.

• Identity document of the major principal of the entity (the entity leader)

Authorities in specific provinces, autonomous regions, and municipalities require that the entity leader be the legal representative of the entity. You must provide the corresponding material based on the identity type of the legal representative. 7.9. Special requirements

7.9.1. A statement required by Guangdong

communication authorities

In Guangdong province, if your website involves financial content, you must provide a website ICP Filing statement. The format is not fixed, but the content must be truthful and complete.

Considerations:

- Describe the business of the company, the website content, and financial-related content in plain language.
- Completely describe the business scope.
- State that never engage in any online financial services before obtaining the permission.
- For enterprise ICP Filing, the statement must be given in the name of the enterprise.
- The statement must have long-term validity instead of being temporary or only valid for a specific stage.

• The statement must be stamped with the official company seal and signed by the legal representative, and the company business license must be attached.

7.9.2. ICP filing regulations for Tianjin

In order to improve the authenticity and accuracy of website filing, Tianjin Communications Administration strictly checks the accuracy of filing information and website content. This topic lists the following notes.

- Individual businesses: Individual businesses must be filed as enterprises. If you have registered an organization name for your business, enter the organization name on your Industrial and Commercial Business License. Otherwise, enter the legal representative name with a remark (individual business) in the brackets after the name of the legal representative. For example, Jack Zhang (individual business).
- Individuals: The actual website name must be the same as the name in the ICP filing information. The website content cannot include information on enterprises and industries. Individuals cannot run e-commerce websites.
- If the ICP number has been issued for more than half a year, the website must be accessible.
- The entity and the website administrators can not be the same person. The same mobile phone number cannot appear in different administrator information.

7.9.3. Website construction proposal

According to the Guangdong provincial authority, domain names with different prefixes (for example, example.com and aliyundoc.com are domain names with different prefixes) must be filed as different websites. If one ICP filing entity has multiple domain names (including filed domain names and the domain names to be filed), such an entity needs to provide the website construction proposal.

If the ICP filing entity is an individual or an enterprise, the following table lists the scenarios which need the website construction proposal:

Information to be included in the website construction proposal

There is no specific template for the website construction proposal. You can create one based on your own website plans, but it must contain the following information:

- Website content and column introduction (with design illustrations).
- Personnel and funding arrangements (including personnel qualification, competency, and background).

? Note If the website is run by an individual, you need to specify whether the individual is full-time or part-time, individual time allocation, personal policy knowledge, and technical competencies.

- Content management system
- Network deployment scheme (including what technologies are used and where the website is deployed).
- Technical measures for network information security.
- Contingency plans.

8.Pre-approval

If your website provides information or services that are related to specific industries, such as news, publishing, medicine, and medical devices, you must obtain a pre-approval before you apply for an Internet Content Provider (ICP) filing. This topic describes the industries that require pre-approvals and the authorities that issue pre-approvals. If your website requires a pre-approval, contact the relevant local authority.

Precautions

- If the name, business scope, website name, or website content of the organization involves the content that requires a pre-approval, you must apply for a pre-approval. Otherwise, the ICP filing application may fail. For more information, see Industries and authorities.
- If the authority that you have consulted informs you that a pre-approval is not required, you must provide remarks or statements as proof when you apply for an ICP filing. For more information, see Remarks or statements to be provided.
- If you are not sure whether pre-approval documents are required when you apply for an ICP filing for your organization or enterprise, consult the customer service by calling 95187 or on the Smart Online page.

Industries and authorities

The following table describes the industries that require pre-approvals and the authorities that issue pre-approvals. You can apply for a pre-approval based on actual conditions. To apply for a pre-approval, you must log on to the Alibaba Cloud ICP Filing system, enter the ICP filing information, select the required pre-approval type, enter the pre-approval number, and then upload the relevant pre-approval documents.

Note If the entered pre-approval information or the uploaded pre-approval documents are invalid, you can modify them based on actual conditions.

- If the ICP filing application has not been submitted for the preliminary review, you can log on to the Alibaba Cloud ICP Filing System on a PC and modify the information as required on the Modify Website Information page.
- If the ICP filing application has been submitted for the preliminary review, you must wait for the Alibaba Cloud reviewer to review the application. During the preliminary review, if the reviewer discovers that your pre-approval information is invalid, your ICP filing application is rejected. In this case, you can log on to the Alibaba Cloud ICP Filing System on a PC and modify the information as required on the Modify Website Information page.

News

Information services of Internet news include the publishing of news information over the Internet, supply of electronic bulletin services on current affairs and politics, and broadcast of communication information on current affairs and politics. News information includes relevant reports and comments on public affairs such as politics, economy, military affairs, diplomacy, and public emergencies. The information service of Internet news can be classified into the following three types:

1. Service providers of Internet news information established by news entities to publish news that is not published and broadcast by the said entities, provide electronic bulletin services on current affairs and politics, and broadcast communication information on current affairs and politics

2. Service providers of Internet news information established by non-news entities to reprint news information, provide electronic bulletin services on current affairs and politics, and broadcast communication information on current affairs and politics

3. Service providers of Internet news information established by news entities to publish news information that is published or broadcast by the said news entities

Publishing

Internet publishing refers to the online broadcast of content by the service providers. Specifically, the service providers choose and edit the content that is produced by themselves or by others and publish or spread the content over the Internet to the users for browsing, reading, use, or downloading. The content comes from different aspects such as books, newspapers, periodicals, audio-visual products, electronic publications, content that is released to the public on other media, and edited content on literature, arts, natural sciences, social sciences, and engineering technology.

All business activities that involve the following content must apply for the Internet Publishing License from relevant authorities: online electronic reading, electronic publications, audio-visual products, Internet books, Internet newspapers, Internet magazines, mobile phone publications, academic publications, art publications, educational publications, and maps on the Internet and mobile networks.

Medicine and medical devices

Based on the *Measures for the Administration of Medicine Information Service over the Internet*, Internet information services of medicine refer to activities that are conducted over the Internet to provide users with medicines and medical devices.

Culture

Based on the *Interim Provisions on the Administration of Internet Culture*, online cultural content refers to cultural goods and services that are created, transmitted, and circulated over the Internet. Examples of online cultural content are online music and cartoons.

Broadcasts, films, and TV programs

This type of online content refers to audio-visual programs that consist of movable pictures or sounds that can be continuously watched or listened to, such as the content on video and live streaming websites. Such content is shot and recorded by using audio-visual recording equipment such as video cameras and recorders.

Education

Pre-approvals of the education sector are applied to educational websites and online schools, such as diploma services, distance education videos, and examination training.

Healthcare

Internet information services of healthcare refer to the supply of medical and health information services to Internet users by launching a medical and health institution website, a disease prevention and health knowledge website, or a disease prevention and health channel on a comprehensive website.

Online taxi hailing

An *Online Taxi Hailing Business Certificate* is required for all enterprises that provide online taxi hailing services or related activities in municipal administrative regions. Online taxi hailing services refer to business operations in which a service platform is constructed based on the Internet technologies. These business operations integrate information on supply and demand, use qualified vehicles and drivers, and provide non-cruising online taxi hailing services. In brief, a company provides online taxi hailing services by using an Internet platform.

Electronic bulletin

Electronic bullet in services refer to the activities of providing Internet users with information publishing conditions in various interactive forms, including electronic bullet in boards, interactive whiteboards, electronic forums, online chat rooms, and message boards.

Note: Based on the *Decision of the State Council on the Fifth Batch of Items Subject to Administrative Examination and Approval at the Management Level to Be Canceled or Delegated to Lower Level,* Article 7 **abolished the pre-approval of electronic bulletin services**.

Finance

If some financial terms appear in the name, business scope, website name, or website content of the organization, you must provide the required approval document that is issued by the financial department when you apply for an ICP filing for your website. The financial terms include exchange, exchange center, finance, asset management, financial management, funds, fund management, investment management, wealth management, equity investment funds, online loans, online lending, P2P, equity crowdfunding, Internet insurance, and payment. Due to the different regulations of different provinces, autonomous regions, and municipalities, the preceding financial terms are for reference only. For more information, check the review result of the ICP filing application.

Note Alibaba Cloud verifies the websites that involve the preceding financial terms on an irregular basis. ICP numbers of websites that violate the regulations are canceled.

For reference, you can consult the following authorities to obtain pre-approvals for financial business:

- For Internet payment business, consult the People's Bank of China.
- For online lending business, such as P2P lending and online small loan business, consult the provincial finance office and the China Banking Regulatory Commission.
- For Internet insurance business, consult the China Insurance Regulatory Commission.
- For Internet trust and Internet consumer finance business, consult the China Banking Regulatory Commission.
- For equity crowdfunding, Internet funds, fund sales, financing, and financing guarantee business, consult the China Securities Regulatory Commission. If you apply for an ICP filing in Jiangsu Province and your website contains information on financing or financing guarantee, you may consult the local economic and information commission.
- For private equity funds, consult the Asset Management Association of China. If you apply for an ICP filing in Jiangsu Province, you must submit approval documents as required by the financial regulator.

The following content describes special circumstances for reference:

- To apply for an ICP filing for a website of charity funds or public funds, you must submit documents such as a filing application document that is verified by the civil affairs department and the letter of guarantee for non-engagement in financial business. If you apply for an ICP filing for such entities in Zhejiang Province, you must submit verification documents that are approved by the financial regulator. Entities without relevant financial permits cannot apply for an ICP filing.
- If your website content is not about finance, you must change the name or business scope of the company. Otherwise, you cannot apply for an ICP filing for the website.

Games

A game must receive a pre-approval before it can be launched and charge fees. In Sichuan Province, the pre-approval is issued by the provincial administration of press, publication, radio, film, and television. In Hubei Province, the pre-approval is issued by the provincial administration of press and publication. In other provinces, the pre-approval must be issued by the Press Bureau of Publicity Department of the CPC Central Committee or the provincial administration of press, publication, radio, film, and television.

Religion

For an ICP filing for online religious information and practices, Guangdong is the only province that requires documented approvals granted by the ethnic and religious affairs commission at the provincial level, municipal level, or district level.

Remarks or statements to be provided

For industries that involve pre-approvals, if the authority informs you that the pre-approval is not required, you can submit a usual ICP filing application for the preliminary review. Based on the feedback of the reviewer, you must provide remarks or statements as proof. The following table describes the required content of the remarks or statements and how to provide them.

? Note

- If the remarks or statements are not accepted based on the regulations of the relevant authority, you must apply for a pre-approval.
- If your website name or website content involves the content that requires a pre-approval, you must apply for a pre-approval. Otherwise, you must modify the website name or website content.
