1 Billing

This topic describes the billing methods and billing rules of Alibaba Cloud Short Message Service (SMS).

SMS supports the pay-as-you-go billing method. You can also purchase SMS resource plans based on your needs. Each resource plan is valid for 180 days. For more information about how to purchase SMS resource plans, see SMS resource plans.

Billing rules

Each SMS message can be up to 140 bytes in length. If a message that you send exceeds 140 bytes in length, SMS separates the message into multiple messages for processing. In this case, the length limit of each message is 134 bytes and the rest 6 bytes are used for splicing messages.

Encoding

Note:

If you send an SMS message by using the HTTP API, check which encoding is used to encode the message. If the message contains only English letters, GSM7 encoding is used. Otherwise, check whether UCS2 encoding is used.
