## Areas of data transfer plans

Each data transfer plan covers an area and the area covers one or more regions. The relation between areas and regions are displayed in the following table.

Data transfer plan areas	Covered regions
Mainland China	China (Qingdao), China (Beijing), China (Zhangjiakou), China (Hohhot), China (Hangzhou), China (Shanghai), and China (Shenzhen)
Regions outside mainland China	Australia (Sydney), US (Virginia), US (Silicon Valley), Germany (Frankfurt), Singapore, Malaysia (Kuala Lumpur), India (Mumbai), and UK (London)
