1.Purchase a data transfer plan

Data transfer plans are easy to use and cost-effective. A data transfer plan takes effect immediately after you purchase it. A data transfer plan is used to offset IPv4 data transfer for pay-by-data-transfer cloud resources until the data transfer plan expires or is exhausted. Supported pay-by-data-transfer cloud resources are: Elastic Compute Service (ECS) instances, elastic IP addresses (EIPs), Server Load Balancer (SLB) instances, and EIP bandwidth plans. EIPs of BGP (Multi-ISP) Pro are not supported.

Context

Before you purchase a data transfer plan, take note of the following rules:

- Each Alibaba Cloud account can own at most 70 data transfer plans that have not expired. You cannot increase the quota. When you purchase a data transfer plan, specify the size of the data transfer plan based on your actual needs.
- When you purchase a data transfer plan, you must specify the area where the data transfer plan is applied. Each area consists of different regions. The following table describes the areas and regions that support data transfer plans.

Area	Region
Mainland China	China (Qingdao), China (Beijing), China (Zhangjiakou), China (Hohhot), China (Ulanqab), China (Hangzhou), China (Shanghai), China (Shenzhen), China (Heyuan), and China (Guangzhou)
China (Hong Kong)	China (Hong Kong)
Regions outside China	Australia (Sydney), US (Virginia), US (Silicon Valley), Germany (Frankfurt), Singapore (Singapore), Malaysia (Kuala Lumpur), India (Mumbai), UK (London), Indonesia (Jakarta), and Japan (Tokyo)

Purchase a data transfer plan

- 1. Log on and open the Data Transfer Plan buy page.
- 2. On the buy page, set the following parameters of the data transfer plan, click **Buy Now**, and then complete the payment.

Parameter	Description
Size	Specify the size of the data transfer plan. The sizes that you can select depend on the subscription duration of the data transfer plan. For more information, refer to the buy page.
Plan	 Specify the area to which the data transfer plan is applied. China Mainland: The data transfer plan is applied to regions within the Chinese mainland. China (Hong Kong): The data transfer plan is applied to the China (Hong Kong) region. Overseas: The data transfer plan is applied to regions outside China.

Parameter	Description	
Expiry Date	Specify the subscription duration of the data transfer plan. Valid values: • 1Month • 1Year You cannot request a refund for data transfer plans that have expired. After a data transfer plan expires, the remaining amount of data transfer is cleared and cannot be transferred to other data transfer plans.	
Quantity	Specify the number of data transfer plans that you want to purchase.	

2. View Data Transfer Plans

Procedure

- 1. Log on to the Alibaba Cloud Billing Management.
- 2. In the left-side navigation pane, click **Resource Packages > Overview**.
- 3. On the **Overview** page, filter the Data Transfer Plans according to the following information, and then click **Search**.
 - o Product: Select Data Transfer Plan.
 - o Traffic Package Status: Select All.
